  not have a visa allowing employment in the United States, or are continuing their education in an accredited
  or bureau-approved postsecondary institution.
- <u>"Graduates Employed in the Field"</u> means graduates who beginning within six months after a student completes the applicable educational program are gainfully employed, whose employment has been reported, and for whom the institution has documented verification of employment. For occupations for which the state requires passing an examination, the six months period begins after the announcement of the examination results for the first examination available after a student completes an applicable educational program.
- <u>"Placement Rate Employed in the Field"</u> is calculated by dividing the number of graduates gainfully employed in the field by the number of graduates available for employment.
- <u>"Number of Graduates Taking Exam"</u> is the number of graduates who took the first available exam in the reported calendar year.
  - <u>"First Available Exam Date"</u> is the date for the first available exam after a student completed a program.
- <u>"Passage Rate"</u> is calculated by dividing the number of graduates who passed the exam by the number of graduates who took the reported licensing exam.
- <u>"Number Who Passed First Available Exam"</u> is the number of graduates who took and passed the first available licensing exam after completing the program.
  - <u>"Salary"</u> is as reported by graduate or graduate's employer.

"No Salary Information Reported" is the number of graduates for whom, after making reasonable attempts, the school was not able to obtain salary information.

#### STUDENT'S RIGHT TO CANCEL

A Student may cancel this agreement at anytime by notifying the School in writing (a "NOTICE OF CANCELLATION" is provided).

After this 100 percent refund cancellation period has passed, the refund to be paid to a student shall be calculated by deducting the registration and STRF fees from the program's total charges for a period of attendance and dividing this figure by the total number of program's clock hours. The quotient is the hourly charge for the instruction. The amount of monies owed by the student for the purpose of calculating a refund is derived by multiplying the total hours the student had attended by the hourly charge for instruction. The amount of the refund to which a student would be entitled (after completing a period of days or weeks of instruction) will be calculated by deducting both the amount monies owed by the students and the non-refundable fees (registration and STRF) from the total charges of the program for the period of attendance (See Example 2 below). There will be no tuition refund for students who have completed 60 percent and more of the period of attendance of the program. The institution will pay or credit refunds within 45 days of a student's cancellation or withdrawal.

You have the right to withdraw from a course of institution at any time. If you withdraw from the course of institution after the period allowed for cancellation of the agreement, which is until the fifth day of class session, or the seventh (7) calendar day after enrollment, whichever is later, the school will remit a refund less a registration fee, if applicable, within 30 days following your withdraw. You are obligated to pay only for educational services rendered and for unreturned equipment. IF THE AMOUNT YOU HAVE PAID IS MORE THANTHE AMOUNT YOU OWE FOR TIME YOU ATTENDED, THEN A REFUND WILL BE MADE WITHIN 30 DAYS OF WITHDRAWAL. IF THE AMOUNT YOU OWE IS MORE THAN THE AMOUNT YOU HAVE ALREADY PAY, THEN WILL HAVE TO MAKE ARRANGEMENTS TO PAY IT. Refund, if any due according to PRO BARBER COLLEGE Refund and cancellation policy will be less the registration fee, Student Tuition Recovery Fund Fee, used kit items and supplies.

REMEMBER YOU MUST CANCEL IN WRITING. You do not have the right to cancel by telephoning the school of failing to attend classes. If you have any complaints, questions, or problem that you can not resolve with the school, write or call the Bureau for Private Postsecondary Education.
